

What Is the 24-Hour Rule for British Airways?

The 24-hour rule for British Airways allows customers to cancel a flight booking within 24 hours of purchase without paying a cancellation fee ++ 1-877-827-8493, provided certain conditions are met. This policy applies only to bookings made directly through British Airways' official channels, such as their website ++ 1-877-827-8493, mobile app, or customer service phone line. If a ticket is booked through a third-party travel agency or online travel platform, the 24-hour cancellation policy may not apply, ++ 1-877-827-8493 and travelers must refer to that agency's terms and conditions. Alternatively, you can contact customer service directly to request the cancellation and refund.
